Position Summary:

Provides therapy services to HIPsters/clients with an emphasis on music, assisting HIPsters/clients with their musical goals and aspirations. Coordinates music therapy services and ensures ethical and effective services are provided based upon best practices.

Essential Functions/Percentage of Time Spent on Each:

- Responsible for providing music therapy services weekly to HIPsters and outside clients, consisting of group and individual sessions. Billable hours determined by Music Therapy Lead (based on need).
- Documents HIPster/client goals and notes on a daily/weekly/monthly basis and maintains detailed HIPster/client music therapy files.
- Completes appropriate HIPster/client assessments and completes/implements treatment plans
- Provides all necessary documentation to the Therapy Billing Specialist on time.
- Collaborates and works cooperatively with therapists and program staff for overall benefit of HIPsters/clients.
- Communicates with parents, caregivers, and providers to discuss progress and performance in therapy, as appropriate.
- Completion of any/all additional tasks or projects that may be assigned by the Director of Programs, Therapy Manager, or Music Therapy Lead.
- Must adhere to all confidentiality guidelines of our HIPsters and their families.
- Supports and participates in the MP HIPster Showcase as scheduling allows.
- Acts as a role model and mentor to our HIPsters, working hard to keep a professional demeanor at all times.

Competencies (Knowledge, skills and abilities):

- Experience working with adults with special needs preferred.
- Understands music therapy methods, including the implementation of therapy plans.



- Able to communicate effectively both verbally and in writing (sign language a plus).
- Must be able to interact effectively on a daily basis with other Music Therapists, Music Therapy Lead, Therapy Manager, and other Staff managers and employees.

Minimum qualifications:

Education:

- Bachelor's Degree in Music Therapy

Experience:

- At least 1 year of clinical experience preferred
- Experience working with Special Needs adults preferred

Specific Skills:

Specialized Knowledge, Licenses, etc.:

- MTBC required
- Proof of Professional Liability insurance required
- Current driver's license, acceptable driving record and valid car insurance required.
- Must be able to clear a background check with no related offenses jeopardizing the integrity of our program.

Supervisory responsibilities:

This is a non-supervisory position which does not directly manage any employee.

Working conditions:
